**SUBJECT:** Parental Notification of Standardized Assessments

This memorandum is being sent to comply with state statute (N.J.S.A. 18A: 7C-6.6) that requires that school districts, charter schools and renaissance school projects, provide parents and guardians with information regarding any state assessment or commercially developed standardized assessment that will be administered over the course of the school year.

It is very important to note that all students may not be administered all assessments. If a student is permitted extra time or any other accommodations as per their 504 or IEP, parent/guardians should contact their guidance office/special services for additional details on accommodations and accessibility options. Students with severe cognitive disabilities may be assigned to take the DLM assessments as prescribed by their IEP team (http://www.nj.gov/education/assessment/accommodations/).
